

OVT Agreement, Non-Exclusive License, and FDA Status

If a participating company opts to have its video hosted by AAOS on the AAOS' Orthopaedic Video Theater ("OVT"), it will be hosted for a minimum of twelve (12) months. - d. AAOS shall own all rights and title to OVT.
- e. AAOS may add language to the video or elsewhere on OVT that the video is sponsored and inclusion of the video on OVT does not imply support or endorsement of Company by AAOS.
- f. AAOS may mention the video in its marketing emails, which may be sent to promote engagement with new videos.
- g. AAOS retains the right to refuse or remove the video if, in AAOS's sole discretion, it violates federal or state laws or regulations, the terms of this Agreement, or if it is inconsistent with AAOS rules, policies or procedures.
- h. Company agrees to grant a non-exclusive license to AAOS to use the Company

- trademarks, trade names, service marks, logotypes, or brand identifiers ("Company Logos") in posting and identifying the video within OVT and in promotional efforts.
- Company agrees to indicate the FDA clearance status of the products featured in the presentation.

Indemnification
