4-3-2022 – Academy BOD Meeting – Approved Minutes

I. Call to Order

The American Academy of Orthopaedic Surgeons Board of Directors virtual meeting was called to order by Kevin J. Bozic, MD, MBA, FAAOS, President, at 7:00 p.m. CDT.
